## SCHOLARSHIP APPLICATION DEADLINE

Each year, Pi Gamma Mu awards 10 scholarships to outstanding members. Four are named scholarships, three are worth \$2,000 each, and the other seven are worth \$1,000 each. These scholarships are primarily intended for first-year graduate work in the social sciences. If you are interested in applying, you should start putting your information together right away. Applications must be fully completed and received at the Pi Gamma Mu office in Winfield with a postmark on or before January 30. Winners will be notified in March, with the grants awarded in September. The Pi Gamma Mu membership directory was in the planning stage for many years. But, now, the preparation effort is coming to an end.

**Monday, December 6**, is the *last* day for members to call the publisher, Harris Connect, to update their records. It is also the *last* day to order a copy of the membership directory.

Dr. Gordon E. Mercer, international president, commented enthusiastically about the fact that many *thousands* of members have contacted the publisher and updated their records. "The Board of Trustees wanted very much to have a comprehensive directory that would truly reflect the vitality of our honor society and the loyalty of our members," the president said. "Without a doubt, this directory will fulfill all of our expectations."

Shipments of the directories to the members who will have ordered them by December 6 will occur in early March. We are certain that every member who possesses a copy will be pleased that his or her name and contact information appear in the directory and will be proud to have the directory on his or her bookshelf. The publisher does *not* expect to be able to provide copies of the directory to any member who has not placed an order by December 6.

## HOW TO CONTACT HARRIS CONNECT

Sue Watters, Pi Gamma Mu's executive director, explained how members can contact Harris Connect. "If a member has received a post card from Harris Connect, he may call the toll-free telephone number-- **(800) 653-8765**--that is printed on the card. The customer-service representative will ask the member for the ID number that is also printed there," said Mrs. Watters. "If a member has *not* received a post card, she may call **(800) 215-5382** and ask to speak to Carol Logue, who will assign an ID number to the member and confirm the member's directory information."

## TRIENNIAL INTERNATIONAL CONVENTION

**"Pi Gamma Mu Honors America's Past, Plans the World's Future"**  
**October 20 – 22, 2011**

Plans are coming together for our next Triennial International Convention. Our hotel, the Holiday Inn National Airport, is in Arlington, VA, but we will be spending most of our time in Washington, D.C. The Metro subway line goes from our hotel into downtown Washington, D.C. Research papers or research poster papers will be presented in a committee room of the U.S. Congress. We hope all chapters will be sending delegations and that delegations will be present to support presentations in the U.S. Congress. We are also planning a simulated student Constitutional Convention to propose amendments to the U.S. Constitution.

**Tour** – on Friday we will have a walking tour of the capital, "It's a Mall World After All" led by Secretary-Treasurer Larry Heck.

**Paper Proposals** – Pi Gamma Mu student members may propose to present papers or posters of their research at the convention. Pi Gamma Mu will pay for one night's lodging at the hotel for each student member whose proposal is accepted and who presents his or her research paper or poster paper at the international convention. Proposals for this convention must be submitted in the form of a completed research paper or, at a minimum, a complete draft of a paper. Students may present their research paper as a poster paper or make a formal presentation.

The chairman of the Committee of Readers is Dr. Charles Hartwig, South/Southwest Regional Chancellor for Pi Gamma Mu. Students should submit their proposal by e-mail to [hartwigc@astate.edu](mailto:hartwigc@astate.edu) (and send a copy to convention-committee chairman Barry D. Friedman at [bfriedman@northgeorgia.edu](mailto:bfriedman@northgeorgia.edu)). Attach the research paper as a Microsoft Word document. Other formats are unacceptable. Proposals must be received by Dr. Hartwig no later than June 1, 2011. We will also have a simulated national student Constitutional Convention for the proposal of amendments to the U. S. Constitution. Delegations should begin to prepare amendment proposals. These should be submitted in advance to **Dr. Barry D. Friedman** so plans can progress on the student Constitutional Convention.

**Service Project** – We are asking delegates to bring a stuffed animal to the convention, perhaps with some kind of state-specific identification such as a state flag or a ribbon with the name of the state on it. The toys will be collected and donated to a local organization. In the past we have given the stuffed animals to a battered-woman's shelter. One of the ideals of Pi Gamma Mu is Social Service, and we want to leave Washington, D.C. knowing that we were able to help some children.

**Hotel** – We will be staying at the Holiday Inn National Airport Hotel in Arlington, VA. The room rate is \$119.00 per night (plus applicable taxes) for up to four people. The hotel is located at 2650 Jefferson Davis Highway; phone is 703-684-7200. Attendees can fly into Ronald Reagan Washington National Airport, and ride the Metrorail to the hotel.

## 2. JAMES MADISON FELLOWSHIP

Also available is the **JAMES MADISON FELLOWSHIP**, which is a national program offering graduate fellowships in every state. **Deadline to apply is March 1, 2011.** The Junior Fellowships are awarded to students who are about to complete, or have recently completed, their undergraduate course of study and plan to begin graduate work on a full-time basis. Junior Fellows have two years to complete their degree.

Senior Fellowships are awarded to teachers who wish to undertake work for a graduate degree on a part-time basis through summer and evening classes. Senior Fellows have up to five years to complete their degree.

The Fellowships are intended exclusively for graduate study leading to a master's degree. James Madison Fellows can attend any accredited institution of higher education in the United States. Each individual entering the program will be expected to pursue and complete a master's degree in one of the following:

1. Master of Arts degree in American history or political science (government and politics)
2. Master of Arts in Teaching degree concentrating on either American Constitutional history (in a history department) or American government, political institutions and political theory.
3. Master of Education degree or the Master of Arts or Master of Science in Education, with a concentration in American history or American government, political institutions, and political theory.

The Fellow's proposed plan of graduate study should contain substantial constitutional course work. Fellows are encouraged to choose institutions which offer courses that closely examine the origins and development of the U.S. Constitution, the evolution of political theory and constitutional law, the effects of the Constitution on society and culture in the United States, or other such topics directly related to the Constitution.

Whatever institution and whichever degree a Fellow selects, at least 12 semester credits (or 18 quarter credits) of constitutional study must be part of the Fellow's program. The institution should accept the six credits earned at Georgetown University by the Fellow at the Foundation's Summer Institute on the Constitution. ## CALLING FOR PAPERS AND POSTER PAPERS

It's that time again; the tri-annual conference in *Washington D.C.* is just around the corner. We want your papers and poster papers. Pi Gamma Mu will pay for one night's lodging at the Arlington, Virginia Holiday Inn National Airport Hotel for each student member whose proposal is accepted and who presents his or her paper at the international convention. There are steps to having your paper or poster paper selected for presentation.

1. Each paper must be complete when submitted. If you are submitting a poster paper a complete overview of what will be on the poster must be submitted in a written paper format.
2. All papers/poster papers must be received by **JUNE 1, 2011** for review. SEND YOUR PAPER OR POSTER PAPER PROPOSAL TO DR. CHARLES HARTWIG, Department of Political Science, Arkansas State University, P.O. Box 1750, State University, AR 72467-1750.

As a past paper presenter I know the hesitation of whether or not to submit a paper for review and possible selection; but having been in your shoes, I can tell you that it was one of the best things that I did as an undergraduate student. The opportunity to present in front of international peers and to receive feedback from other Pi Gamma Mu members from around the world was astounding. Every paper is received well and many questions and discussions arise among all that participate.

This is also an opportunity to expand research horizons and interests in other areas. Also the networking opportunities of the Triennial Conference must be highlighted. The whole weekend is a blast with academics highlighted in a student centered atmosphere that Pi Gamma Mu has dedicated itself to fullest. I cannot wait to hear the presentations at the conference, not to mention see the poster papers that will be presented.

## NEW YORK NU CHAPTER AT ST. JOSEPH'S COLLEGE WINS ACHS SPONSORED GRANT

The goal of the ACHS Adviser Grant Program on Social Responsibility Award is to encourage cross-campus collaboration and new initiatives among student organizations related to social responsibility. Six \$500 grants are available for pilot projects to achieve the following objective:

- Conduct initiative or pilot project related to social responsibility, or
- Strengthen current social responsibility or sustainability initiative of individuals and the campus.

Last year the Pennsylvania Alpha Omicron chapter at **Washington & Jefferson College** was the winner of one of these grants. We are very proud to announce that another Pi Gamma Mu chapter has been awarded a grant for this year's competition.

The New York Nu Chapter at **St. Joseph's College** was selected. Their grant will implement a healthy eating/mentoring program conducted by students of the St. Joseph's College for the young people of the Montfort Therapeutic Residence. The program will also include other students at St. Joseph's College as mentors. The purpose of the program will be to promote healthy eating options. Using a hands-on approach, participants of the program will learn how to prepare healthy meals along side their student mentor and under the watchful eye of supervising adults.

## CHAPTERS IN ACTION

At **University of Nebraska at Omaha**, the Nebraska Epsilon chapter gathered materials for a local low-income housing facility occupied mostly by recent refugees from Sudan. They gathered a substantial quantity of household supplies, personal care items, childcare items, and school supplies.

The Philippine Alpha chapter at **University of the Philippines** reactivated its professorial chair, known as the Pi Gamma Mu Professorial Chair. They plan to award one thesis and one dissertation grant per year to a graduate student.

At the Massachusetts Delta chapter at **Wheelock College**, they created 75 birthday gift bags for a local homeless shelter in Boston. The bags contained pencils, temporary tattoos, joke books, bubbles, and more. The bags were kept in a storage room at a shelter so that parents can give their children a present on their birthdays. They worked with other organizations on campus to provide five families and over 10 children with gifts for the holiday season. We encouraged staff, students, and organizations to spin "the giving wheel" that would land on a wish list item for a child. They collected clothes, toys and more for local families in Boston. They created new crayons from melted old crayons to be sold for profit by an organization that will benefit oncology units of hospitals. They collected over \$600 for an organization called Music for Haiti by orchestrating a yard sale using objects from students' dorm rooms. They donated all the remaining items to a local homeless shelter. In addition to those projects, they completed three community service events per semester including events such as: reading to preschool children, creating cards for soldiers overseas, working with Make-A-Wish, participating in charity walks, and volunteering in local food banks.

The Georgia Kappa chapter at **North Georgia College & State University** participated in the Kiva micro-loan project. The Council of Honor Societies has maintained a \$250 fund, which is used to partially fund 10 micro-loans to foreign entrepreneurs at any given time. (As an entrepreneur repays her loan, they then commit the \$25 portion to a new applicant.) The Georgia Kappa chapter provided 60 percent of the \$250 fund.

The Louisiana Eta chapter at **Grambling State University** has been engaged in fulfilling the seven ideals of Pi Gamma Mu. These activities have mainly reflected service, research, scholarship, and professional involvement. They researched and gave presentations on aging and longevity, health care reform, health care disparities at the Association of Social and Behavioral Scientists, the University of Kentucky-Summer Series on Aging, and the Mid-South Sociological Association. Their community services included flower distribution of flowers on Mother's and Father's Day at Princeton Long-term Care Facility. They chapter distributed Easter baskets and teddy bears to hospitalized children. Recruited faculty, staff and community members to be pledged sponsors of Project BEAP (Black Empowerment Apprenticeship Program). These sponsors will be donating a minimum of \$500 over a five year period for school supplies, stipends, and scholarships for at-risk children and youth.

This chapter placed flags in the Grambling community cemetery on Memorial Day. They have an ongoing preservation and beautification of the cemetery where the founder of Grambling State University is buried. They had a Fall Sock drive for residents of the Veterans Home in Monroe, LA. They involved the BEAP youth in data collection in the nursing home and the cemetery.

## 2010 PRESIDENT'S HIGHER EDUCATION COMMUNITY SERVICE HONOR ROLL

As an Honor Society, our organization has a commitment to achievement in the higher education community. The 2010 President's Higher Education Community Service Honor Roll honors colleges and universities for their achievements in community service.

Applications for the 2010 President's Honor Roll will be accepted in either or both categories for service performed during the 2009-2010 academic year:

**General Community Service** recognizes the quality of, quantity of, and commitment to community service initiatives at a college or university. This category will reflect the best practices of community service and service-learning, such as long-term campus-community partnerships and measurable community outcomes as a result of the service.

**Special Focus Area** recognizes exemplary initiatives aligned with the President's education and innovation priorities.

Six institutions – three from each category – will be named as Presidential Award winners.

In addition, the Honor Roll's "With Distinction" recognition will be given to those applicants that display strong levels of institutional commitment, provide a compelling case for partnerships that produce measurable impact in the community, and have a Federal Work-Study community service percentage of at least 15% or above. An institution will be named to the Honor Roll if the service described is deemed substantial, relevant and meaningful, and achieves measurable impacts in the community.

The deadline for submitting applications is December 16th .

## SCHOLARSHIP WINNERS ANNOUNCED

After much deliberation on the part of the Scholarship Committee, Chairman Dr. Charles McClellan recommended the following scholarship winners to the Board of Trustees. Each of these candidates has met the expectations of the trustees who are pleased to award the scholarships to:



The Marvel Stockwell Scholarship was given to **Angela Bergkamp**. She graduated from Newman University where she joined the Kansas Theta chapter. She is now in the Social Work program at Newman University. At the age of eleven Bergkamp saw abuse and injustice in her neighborhood and decided that she wanted to work with the marginalized and oppressed. She has a minor in Spanish and wants to work with the Latino population. Her background includes "working in impoverished

countries doing mission work, working in the service spectrum of schools, and in coordinating groups for service and community involvement.



**Ashley Warchol** is the recipient of the \$2,000 Carroll Parish Scholarship. She joined the Illinois Rho chapter at Eureka College. She is now attending The School of Professional Psychology at Forest Institute in Springfield, MO. Her plan is to received her Doctorate in Psychology and become a clinical psychologist. Warchol also has a minor in Spanish and interned with Berpiztu Elkartea, a non-profit organization located in Spain. She relates that, "while assisting at a local homeless shelter and at area

nursing homes, I have conversed with the residents, many of whom just need someone to listen respectfully to them rather than give advice or dismiss them."

"The Dan Quigley Law Scholarship, which honors the memory of Pi Gamma Mu's long-time corporate attorney, is given to **Jessica Archer**. Archer is a member of the North Carolina Mu chapter at Campbell University. She is now matriculating at the Norman Adrian Wiggins School of Law at Campbell University. Her desire is "to be an advocate for children, because they are the innocent ones, the defenseless, and the ones whose lives can be so drastically altered by the decisions of others. I have a passion for helping children who may be abused, neglected, or malnourished because every child deserves the opportunity to grow and learn, but many are scarred by difficult lives and need help."



Winner of the \$2,000 Effie Urquhart Scholarship is **Michael Staib** from the New York Tau chapter at Pace University. He is now matriculating at Pace University Law School. Staib reports that, "As a proud American, I remain morally compelled to preserve our constitutional foundation; the democratic framework that fundamentally forms American jurisprudence. To me, a reputable lawyer maintains unvarnished integrity, virtuously defending her/his clients' rights and fiduciary interests in the most competent manner possible." He interned at the Yonkers Westchester D.A.'s Office, and was a Legal Assistant analyzing Collection Law cases. While working at Campbell Law Offices, he drafted Bills of Particulars and implemented various legal responsibilities.



**The following were chosen for the \$1,000 Pi Gamma Mu scholarships:**



**Krysta Martinez** joined Pi Gamma Mu at the Philippine Alpha chapter at University of the Philippines. She is now working toward her Masters Degree in International Relations at the IE School of Arts and Humanities in Madrid, Spain. She plans for a career in International Development Management. Her goal is to "work for the United Nations in meeting the Millennium Development Goals of countries struggling to catch up – goals I find time-bound, measurable and actionable." She also hopes to concentrate on "meeting the development goals of my own country by working as a consultant to the government and being our country's representative to international forums...then, in the later part of my career, I wish to train future international development managers by sharing my life-long work teaching as a professor."

**Maureen Normand** is attending the Smith College School for Social Work. Normand joined Pi Gamma Mu at Springfield College's Massachusetts Epsilon chapter. Normand stated that she is "fascinated by the subject of human growth and development and the effects of abuse on the human psyche." She hopes to "come alongside oppressed, hurting, and disadvantaged people in order to assist in the healing process." Normand has had 10 years of volunteer work including working with women recovering from substance abuse, counseling with women in a correctional facility, and volunteering in a court system as an advocate in a domestic violence unit. She has chosen Clinical Mental Health Counseling/Social Work as her profession.



**Katherine Risley** joined the Illinois Gamma chapter at Bradley University. She is now in the Social Work program at George Warren Brown School of Social Work at Washington University in St. Louis. Risley said, "I plan to pursue programs such as foster care, adoption, crisis nurseries, homeless shelters, family counseling, as well as other family services." She is learning American Sign Language to be able to communicate with the Deaf community. At the St. Louis Crisis Nursery where she interned, she was trained in developmental assessments, therapeutic counseling, and crisis interventions. She hopes to value the client's well being, build relationships, provide a necessary service, and advocate for social justice.

**Kevin Steiner** is now attending the Masters of Applied Sciences in Economics program at Marquette University and preparing for a career in consulting, market analysis and teaching. He joined Pi Gamma Mu through the Wisconsin Gamma chapter at St. Norbert College. He hopes to do business consulting and eventually become a college professor. According to Steiner, "I feel that economics is an extremely important perspective to convey since it is so vital not only to business, but personal decision making as well."
